## Biography

Kevin also represents private-property owners and governmental agencies across New York State in connection with acquisitions for public projects, litigating property-valuation issues to determine just compensation and ensuring compliance with the requirements of the Eminent Domain Procedure Law (EDPL) and the State Environmental Quality Review Act (SEQRA). In addition to property-valuation matters, Kevin represents clients in environmental, commercial litigation, and land-use matters.

Kevin is also an experienced appellate practitioner, having served as a principal law clerk to the chief judge of the NYS Court of Appeals before entering private practice. - Successfully defended a multi-national corporation against a lawsuit claiming the operation of a 13,000+ acre underground mining operation had not been subjected to an adequate environmental impact review.
