Representative Experience

- Represented a developer in two related lawsuits involving a tenants association's assignment of its rights under the DC Tenant Opportunity to Purchase Act (TOPA) to purchase a \$40 million high-rise residential apartment building. Obtained an injunction after the trial enjoining the tenants association from assigning its TOPA rights. Successfully negotiated a court-approved settlement that resulted in the assignment of the tenants association's TOPA rights to another developer in return for a significant payment to our client.
- Represented a public national real estate investment trust in a multiparty, complex lawsuit involving the construction of a mixed-use 19-story masonry building at a \$300 million multi-use development project and claims of defective design and construction totaling more than \$16 million. After extensive fact and expert discovery, obtained a favorable settlement in complex mediation.
- Represented a commercial designer and fabricator of reinforced earth retaining walls in a multimillion-dollar action brought by a municipality related to the failure of two walls. After an extensive evidentiary hearing before the panel of arbitrators, obtained a favorable ruling awarding the claimant a fraction of the amount sought.
- Served as lead defense counsel in a multimillion-dollar nationwide class action brought by water treatment facilities in Louisiana and Ohio to recover the cost of monitoring and removing chemicals from public water supplies under the Safe Drinking Water Act. Obtained summary judgment for the defendant and affirmance on appeal.
- Represented the owner of a multimillion-dollar home in a construction contract dispute with the builder. Stayed the builder's mechanic's lien action by initiating an AAA

arbitration proceeding against the builder, which resulted in a prompt and favorable settlement for the owner.
