# **United Nations Issues Scathing Report on US Poverty**


The recently issued UN report on US poverty created yet another furor on both the left and right sides of the political aisle. While there are ongoing debates about how to measure poverty and the severity of poverty in the United States, it is undeniable that there is a significant portion of our country's population that struggles to meet the challenges of everyday life. American poverty is an issue that the nation will continue to grapple with for the foreseeable future.

The most recent US Census Bureau report on income and poverty in the United States from 2016 notes that more than 40 million people—nearly 13 percent of the population—live in poverty. Some studies additionally suggest that, at some point during their adult lives, most Americans will spend at least one year below the poverty line.

Earlier this year, the NYS Community Action Association issued its 11th Annual NYS Poverty Report. That report estimates that, in the state alone, nearly 3 million individuals live in povertyover 900,000 of whom are children under age 18.

If you want to continue the discussion or learn more about issues and challenges surrounding American poverty, consider these options:

- Play the internationally acclaimed online game <u>Spent</u>, hosted by nonprofit Urban Ministries of Durham, and see if you can make it through a month on \$1,000 while facing real-life dilemmas such as, "Do you make a healthy meal or keep the lights on?" and "Hope your sick daughter gets better on her own or risk your job by leaving early to take her to the doctor?" For pro bono attorneys especially, it can be an eye-opening experience.
- Seek to educate yourself with literature like the New York *Times* best-selling *Hilbilly Elegy: A Memoir of a Family and* Culture in Crisis, which presents a sociological analysis of poverty in Appalachia.
- Volunteer with friends or colleagues to give back to those living in poverty in your own communities. You'll not only help those in need, but you can get to know individuals and stories you may never have experienced otherwise.

# 2018 Barclay Damon Community Days



## SYRACUSE - Wadsworth Park

Members of the Syracuse office participated in its annual Community Day on April 19 by cleaning up Wadsworth Park. The office partnered with the City of Syracuse as part of its Earth Day efforts. Despite the unseasonably cold weather, Barclay Damon volunteers braved the conditions to pick up leaves, sticks, and other debris, preparing the Little League baseball field for the season opener, and cutting back brush at several rain gardens.



### **ROCHESTER - Foodlink Urban Farm**

Foodlink's Lexington Avenue Urban Farm serves more than 60 families, many of whom are Nepalese, Bhutanese, and Somali refugees. In October 2017, the farm was vandalized. Equipment was stolen and sections of the perimeter fence and the hoop house were damaged. Probably the most disheartening aspect of all of this was the damage done to multiple fruit trees, all of which were a few years old and would have likely borne fruit this year. On May 17, members of the Rochester office volunteered at the farm. Participants built and secured tomato cages, put down weed barriers, planted and fertilized fruit trees, weeded, and composted—all while avoiding 50,000 bees and one snake. Nathaniel Mich and the other Foodlink staff were very appreciative of the team's efforts, and the Rochester office hopes to schedule a trip back to the farm in a couple of months to see its progress mid-growing season.



### BUFFALO - Harmac Medical Products' Bailey Green Initiative

The Bailey Green initiative was started in 2008 by firm client Harmac Medical Products to clean up the longneglected Bailey Green neighborhood on the city's East Side. On June 15, members of the Buffalo office spent an afternoon cleaning up the Bailey Green neighborhood's vacant lots and sidewalks, sweeping up debris and filling 11 garbage totes with removed trash. The team's work drew praise from community members, including a 40-year Baily Green resident hindered by arthritis in her cleaning efforts who, when interviewed by the *Buffalo Law Journal*, said, "It's a marvelous thing. I'm so appreciative. I couldn't ask for anything better." The Bailey Green initiative has also yielded an urban farm and several new houses built with the help of partners such as Habitat for Humanity. One of the larger lots in the heart of Bailey Green will be transformed into a park, with a pathway connecting other streets in the neighborhood.

# John Langan Presents 10th Annual Monique Emdin Award

In memory of Monique Emdin, a former Barclay Damon associate who tragically passed away from a rare form of stomach cancer in March 2008, the firm established the Annual Monique E. Emdin Memorial Award at the University at Buffalo School of Law in conjunction with Monique's church, Bethesda World Harvest International. The award is presented annually at the university's Students of Color Dinner to one or more graduating seniors who are members of groups traditionally underrepresented in the legal profession and who demonstrate a commitment

# Pro Bono Case Note

Albany office attorney Maggie Rossi recently secured a victory on behalf of a pro bono client facing the loss of her livelihood working as a nurse as a result of being placed on the Medicaid excluded provider list by the NYS Office of the Medicaid Inspector General, essentially prohibiting her from being employed by any entity that accepts a government health care program. This meant that she could not practice in any health care facility.

The client was placed on the list after her license was suspended by the Office of Professional Conduct—a voluntary suspension, as the client chose to seek treatment for drug addiction and entered into an agreement with the Statewide Peer Assistance Program for Nurses. When she approached Barclay Damon for legal aid, she had been sober since June 2016, completed an inpatient substance abuse program, and was currently in an outpatient program.

Despite the OPC reinstating her license in September 2017 and the US Department of Health & Human Services' Office of Inspector General removing her from its own list in January 2018, the OMIG repeatedly denied the request to have the client removed from the state exclusion list, indicating that the client posed a threat to patients. After Maggie's dedicated appeal on behalf of the client, though, the OMIG finally agreed to remove the client's exclusion, opening the door for her to reenter her career. to community service, including significant service in faith-based communities, and who have made a significant impact at the School of Law.



In recognition of the 10th year of Monique's passing, Monique's brothers, her former pastor, and John Langan all spoke about Monique's remarkable personality, achievements, and influence during a life that was tragically cut short. John also spoke about the firm's continuing commitment to diversity and inclusion prior to presenting the award to Donnell Gibson Jr.
