Description: The New York State Department of Health announces the availability of funds under the Statewide Health Care Facility Transformation Program III, established pursuant to Section 2825-f of the Public Health Law. The objective of the Statewide Health Care Facility Transformation Program III is to provide grants in support of capital projects, debt retirement, working capital or other non-capital projects that facilitate health care transformation activities including, but not limited to, merger. consolidation, acquisition or other activities intended to create financially sustainable systems of care, preserve or expand essential health care services, modernize obsolete facility physical plants and infrastructure, foster participation in alternative payment arrangements, to increase the quality of resident care or experience for residential health care facilities, or improve health information technology infrastructure, including telehealth, to strengthen the acute, post-acute and long-term care continuum.

> A total of up to \$208,294,869 is available under this Request for Applications (RFA #18406) to health care providers that are deemed by the Commissioner to fulfill or will fulfill a health care need for acute inpatient, outpatient, primary, home care, assisted living, adult care, hospice, or residential health care services in a community. A minimum of \$529,611 of this total amount is available for community-based health care providers, which are defined as diagnostic and treatment centers, mental health and alcohol and substance abuse treatment clinics, clinics serving the intellectually and developmentally disabled population, and primary care, home care and hospice providers. A minimum of \$23,138,160 must be awarded to residential health care facilities. Up to \$5,000,000 of the total awarded funds may be made to hospitals designated as Regional Perinatal Centers to establish telehealth applications

Applications must be submitted in Grants Gateway by 4:00 PM on Wednesday, January 12, 2022. For application information, visit the New York State Department of Health website at http://www.health.ny.gov/funding/.
